1. You will have the use of the kitchen to store, heat and assemble food.
2. Children are **NOT PERMITTED** in the upstairs lounge without **ADULT** supervision.
3. All decorations are to be removed and placed in trash
4. Tables are to be returned to their original positions.
5. Chairs are to be placed on top of tables.
6. All trash is to be placed in outside dumpsters.
7. All food and drink must be removed immediately after party.
8. Extra chairs and tables are to be stored in the coatroom.
9. If excessive clean up is involved, the member will be billed.
10. The use of a smoke machines is strictly prohibited
11. Cars **MUST NOT BE** parked on both sides of road – There must be access for emergency vehicles.

DECORATIONS ARE NOT TO BE STAPLED, TACKED, TAPED, OR GLUED TO WALLS OR WOODWORK. DECORATIONS ARE TO BE ATTACHED TO TABLES ONLY. IF THERE IS ANY DAMAGE TO THE WALLS, WOODWORK, ETC., THE MEMBER WILL BE BILLED.

DO NOT TIE OR STAPLE BALLOONS/SIGNS TO THE CYC SIGN AT THE TOP OF THE DRIVEWAY. YOU MAY ATTACH BALLOONS TO THE STEEL ROD LOCATED NEAR THE CYC SIGN.

FOOD SERVICE TABLES ARE TO BE PLACED IN THE LOBBY AREA NEAR THE COAT ROOM. FOOD SERVICE TABLES ARE NOT TO BE PLACED ON THE CARPETED DINING AREA OR ON THE DANCE FLOOR.

CYC IS A SMOKE FREE FACILITY. SMOKING IS NOT PERMITTED INSIDE THE CLUBHOUSE.

CYC MEMBERS CAN RENT THE CLUB FOR IMMEDIATE FAMILY MEMBERS. CYC MEMBER MUST BE PRESENT AT THE FUNCTION, AND ALL CHECKS MUST BE WRITTEN BY THE CYC MEMBER. MEMBER AND/OR SPOUSE MUST BE PRESENT AT ALL TIMES (SETUP, FUNCTION, CLEANUP). FUNCTIONS MUST CONCLUDE BY MIDNIGHT.

NOTE: The Cortlandt Yacht Club's liquor license does not cover private parties. Member is responsible for any alcoholic beverages consumed on the premises. MEMBER IS NOT PERMITTED TO CHARGE ADMISSION FEES OR CHARGE FOR ALCOHOLIC BEVERAGES.

Cancellation policy:
