- on land storage. General umbrella liabilities with no vessel listed are not acceptable. If not insured, boat will be removed from the Marina, at the Licensee's expense. Each Licensee will be held responsible for damages he/she causes to other boats in the Marina or to the structures or facilities thereof, whether caused by negligence or not. A fine of \$250 will be imposed for uninsured vessels per month plus any applicable late fees.
- C. Cortlandt Yacht Club shall be named as "Additional insured" Note: Specifying CYC as the "Mooring or Storage Location" is not acceptable as it does not add CYC as an insured party. Licensee must furnish a copy of a currentvalid boat registration or documentation; otherwise the boat will not be launched or hauled. A fine of \$250 will be imposed for unregistered/uninsured vessels per month plus any applicable late fees when boat is at CYC..
- D. Licensee will provide the valid Insurance Policy **Declaration Page** upon renewal of insurance to Cortlandt Yacht Club prior to expiration date of policy; otherwise boat will not be launched or hauled. This page is to be submitted via hard copy by US mail or dropped off in the safe at the CYC office.

- E. Boats shall be secured in their berths in an acceptable manner. No rope or electrical lines can cross finger slips or docks at any time. **No fishing or swimming off docks in Marina**. Kayak use in designated area.
- F. Summer season is April 15^{th 1} through October 1st. Boats not wintering at the Marina must be out of the Marina by October 15th. All Licensees will remove all watercraft from the water by the Sunday after October 15th or be subject to a \$250.00 fine. If your boat remains in a slip or on land, all provisions in this signed Terms of Agreement remain in effect until your boat either leaves the marina or a new Terms of Agreement is signed by you. Licensee will use drop clothes to protect the ground when scraping or painting the boat bottom. Please dispose of all garbage, including shrink wrap, in the marked containers provided by CYC.
- G. Licensee must furnish the Marina a Cell phone and additional telephone number plus an E-Mail address. Should a need arise and the Marina is unable to contact the Licensee, the Licensee hereby grants the Marina authority to take whatever action is necessary to respond to the situation, i.e. move Licensee's boat without liability to the Marina should damages occur.
- H. The Licensee agrees to abide by guidelines for Licensees and acknowledges the receipt of the Cortlandt Yacht Club guidelines with this agreement. Parking is prohibited inside the white lines on the roadway.
- I. Pool passes are \$50 per person up to 4 passes. If you purchase at least 1 pass you will get 1 pass free. (Only 1 free pass per Licensee)
- 3. When a Licensee expects to vacate a berth for 2 days or more (weekend trip and boating vacations), he/she must notify the Fleet Captain who may lease the berth during Licensee's absence. A Licensee <a href="may not "exchange" berths without written permission of the Fleet Captain. Boat owner who pay for a Summer Slip cannot occupy that slip with another boat that's not Insured or Registered to the owner who paid for that slip and no vessel can occupy a slip at CYC without express authorization by the Fleet Captain. Initials.
- 4. The Licensee is responsible for outside contractor's actions and/or service organizations actions while doing work on his/her boat. Outside contractors must provide proof of insurance to the Marina before work is to commence. **Initials**
- 5. Licensee may not use Marina to store boating items, boat stands, ladders, coolers, water toys, dock boxes, etc. Shareholders only are permitted the use of dock boxes. Licensee cannot affix anything to the docks or modify slip (Drilling of holes into the wood is strictly forbidden). All items including, ropes, hoses. electrical cords, mats, etc. must be removed at hauling or prior to boat leaving marina. Any item left at the slip will be discarded at time of removal. **Initials**
- 6. Licensee and their guests agree to conduct themselves in the Marina in a manner that avoids creating an annoyance, hazard or nuisance to the Marina or other Licensees. This includes good housekeeping, proper sanitation practices and the use of trash compactors. Inappropriate behavior including but not limited to abusive behavior, foul language and fireworks of any kind are strictly prohibited on CYC Property. Any Damage caused by Licensee, their Guests or Contractors is the responsibility of the Licensee to make repairs or replace the damaged CYC property Initials
- 7. There shall be no gasoline fueling of boats or PWC's within the marina. No charcoal or open fires are permitted in the boat basin. Gas grills are provided for Licensee use and convenience. Initials
- 8. All halyards must be tied away from the mast before leaving the boat. Trailers must be clearly marked with owner's name.

- 9. Young children shall be under the supervision of an adult at all times and children under 12 must wear PFD's when on the docks or boats. **Initials**
- 10. There shall be **NO** bicycle riding, in-line skating, skateboarding, etc. operation of remote control cars, boats, drones, etc. is strictly prohibited on CYC property at any time. Parking on Waterfront is for Owner Member use only, no exceptions. Licensee and their guests can park in designated areas. Do not block dry hydrants or work areas. **Initials**
- 11. The Licensee shall adhere to all environmental laws and shall keep the lands and waters of the Marina clean and free from human and animal waste, oil and fuel spills and other toxic products identified by federal, state and local governments. Dogs must be on a leash, at all times, and their waste must be disposed properly. No Livestock allowed at CYC property.

- 12. In the event of an infraction of the rules and regulations in this agreement, the Marina may, at its sole option, cancel this agreement upon written notice, and the Licensee shall forthwith remove his/her boat(s) and shall nevertheless remain liable for all outstanding charges. <u>Initials</u>

A.	In the event that the Licensee fails to pay any amount due to the Marina within the prevailing time period, the Marina may detain any of the Licensee's boat(s) on its property, until such sum is paid. A notice of lien will be sent to the Licensee, and if the amount is still not paid 15 days after the notice, the Marina may cause the boat(s) to be sold either at public or private auction retaining any amount due the Marina from the proceeds of the sale. Licensee is responsible for all legal fees and repossession fees of this action. Initials
В.	First half of the summer season charges must be paid by January 31 st . On February 1 st a late fee, the greater of \$25.00 or 1.5% will be assessed, on total invoice. Fee will be charged monthly. Initials
C.	Second half of summer season charges must be paid by March 31 st . On April 1 st a late fee, the greater of \$25.00 or 1.5% will be assessed, on total invoice. Fee will be charged monthly. Initials
D.	A slip will not be guaranteed if the 1 st half is not paid by January 31 st and/or if full payment is not received by March 31 st . The slip will be returned to a pool of licensee's awaiting a slip assignment. Initials
E.	Winter Storage will not be guaranteed if full payment is not made by October 1 st . Licensee must supply jack stands for storage and when not in use, the stands must be removed from CYC property. No Exceptions. Initials
F.	Any vessel or trailer that is on brought on or returned to CYC property and/or any trailer or vessel on a trailer that is moved without the Fleet Captains authorization is subject to a \$250 fine. If you have a trailer on CYC property and utilize jack stands to store your boat and trailer remains on CYC property, the Licensee will be charged \$25.00 per day unless notification to the Fleet Captain for repairs which are temporary. Boat will then be returned to the water or trailer. Initials
